Ron reported income for the month was \$75,558.58 and expenses were \$134,718.63, leaving a deficit for the month of \$59,161.07. These figures are projected and everything is currently within budget and on budget.

General Managers Report: Mike Dopslaff

Mike Reported that Play for the months of June and July is up and it is the best since 2010 & 2011 seasons. Board feels that it is due to the fact that the course is in great shape, and the great job the maintenance staff is doing. He also informed the board that the club will be changing cleaning services starting Sept. 1st. The new service will be Jana King. This company is much larger and more dependable than the past company and the service will be better at no additional cost. He also updated the board on the status of the \$400.00 Assessment. Collections have been better than expected. We have collected from 178 certificate holders; 136 of which are dues paying members and 42 are certificate holders, 88 are not paid as of yet and will be sent notices as such.

Mike also said that there are some concerns that the Capital contributions may now be taxable. After some discussion a Motion by Jim Menditto, 2nd by Jackie Knight that the board would like a second opinion, but in any case it would not affect any members. Motion Passed Unanimously

Seda reported that the restrooms on #17 has been painted and the walkways will be done at a later date. The restrooms on #6 still need to be done, but they also need much more work prior to them being painted (new doors, soffit repair, plumbing repair, and windows etc.)

Seda Reported that Jason has completed the Beautification projects on #9. His crew has planted bushes along the bag drop area and the redesign to #7 is coming along just fine. The committee also plans to replace the Fire Bushes that were damaged due to the hurricane.
